Mrs. Kunzelman - Testing is starting up tomorrow with our 5th graders. Two weeks ago we had the pleasure of Lion Heart Experience come to do district wide presentations about self worth and value. We are working on how we can continue to carry along that message.

Mr. Trapp - College board assessment was last week and testing throughout the grades. We have had several field trips recently and upcoming including a trip to MSU, personal finance speakers coming into the classroom, Holocaust museum and 7th graders going to Detroit Institute of Arts. Here are some upcoming important dates : May 8th Senior Portfolios, May 14th Spring Choir concert at 7:15 pm, May 22nd Honors night, June 1st Graduation.

Mrs. Hodgson - We are working on transition planning on where we are going for fall and how we are going to get there. We have summer retreat days lined up. We are starting to look at data from the spring data that has come in. The Lion Heart Experience has provided some language to help us talk about things. We are working on documenting everything to make sure everything is easy to find.

Ms. Jennett - We are in the final stretch for IEPs right now. The Lion Heart Experience assembly has come up in IEP meetings and how impactful it has been to their students. Kudos to the high school special education team who was very helpful during testing week.

Ms. Clear - Questions posed about 7 routes. We have 2 buses 63-70 students and 5 buses have 75-83 students (every other week students). Route times for 3 students are 107 mins, 7 kids 90 minutes. We have another sub driver starting and is doing amazing. We have 6 available sub drivers. There is a bus parked out front that has the outside and inside cameras. Question (Gancer) do we need another route? Yes. I am working on re-routing to try to smooth things out. Our routing system is outdated. George & Son's in Stockbridge can do commercial tires.

Keven : Transportation needs to be added to the agenda in the future to discuss further.
